AT A GLANCE

A plain-language summary. The numbered clauses below are what legally applies.

- You keep the copyright. We receive a licence, not ownership.
- The licence is limited to running and promoting this Service.
- It is non-exclusive: you may publish the same note anywhere else.
- You can withdraw a note at any time and the licence ends for future use.
- We will not sell your work, license it onward, or use it to train models.

1. What this agreement is

- 1.1 This agreement takes effect each time you submit content to the Service and governs what we may do with that content.
- 1.2 It forms part of the Terms of Use and is to be read with the Copyright and Intellectual Property Policy.
- 1.3 "Contribution" means any note, document, image, question, answer, comment or other material you submit.
- 1.4 A separate licence arises for each Contribution, on the terms in force when it is submitted.
- 1.5 Nothing in this agreement obliges us to publish, retain or continue to publish any Contribution.

2. The rights you keep

- 2.1 You retain full ownership of the copyright in your Contribution.
- 2.2 You retain the right to publish the same Contribution elsewhere, on any terms, at any time, without telling us.
- 2.3 You retain the right to be identified as its author, and we display your name with it.

- 2.4 You retain the right to object to derogatory treatment of your work.
- 2.5 You retain the right to withdraw the Contribution from the Service.
- 2.6 You retain every right not expressly granted below.

3. The licence you grant

- 3.1 You grant us a worldwide, non-exclusive, royalty-free licence to host, store, back up, reproduce, reformat, display, transmit and distribute the Contribution through the Service.
- 3.2 The licence includes the right to make technical copies necessary to operate the Service, including caching, replication across servers, thumbnails, previews and search indexes.
- 3.3 The licence includes the right to convert the Contribution into other formats where necessary for display or download, including generating a cover image or a text preview.
- 3.4 The licence includes the right to display the Contribution in the mobile application and to permit offline retention on a user's device.
- 3.5 The licence includes the right to display an extract, a title or a thumbnail of the Contribution in listings, search results, feeds and social previews.
- 3.6 The licence includes the right to show the Contribution in material promoting the Service, provided your attribution is preserved.
- 3.7 The licence is royalty-free. Contributors are not paid, and the Service earns no revenue from Contributions.
- 3.8 The licence is sub-licensable only to our hosting and content-delivery providers, and only to the extent necessary to deliver the Contribution to users.

This is a deliberately narrow sub-licence. It exists so that a storage provider can lawfully hold the file, not so that we can pass your work to a third party for their own use.

4. Limits we accept

- 4.1 We will not sell your Contribution.
- 4.2 We will not license your Contribution to a third party for that party's own commercial exploitation.
- 4.3 We will not place your Contribution behind a paywall or use it as a paid product.
- 4.4 We will not use your Contribution to train, fine-tune or evaluate a machine learning model, and we will not permit a third party to do so, without your separate express consent.
- 4.5 We will not remove your name from your Contribution while it is published.
- 4.6 We will not materially alter the substance of your Contribution. Formatting, compression and metadata changes necessary for display are permitted.
- 4.7 We will not use your name or image to endorse anything beyond identifying you as the author of your Contribution.
- 4.8 We will not assert any ownership right over your Contribution.

5. Your warranties

- 5.1 You warrant that the Contribution is your own original work, or that you hold all rights necessary to submit it and to grant this licence.
- 5.2 You warrant that the Contribution does not infringe any third party's copyright, trademark, moral rights,

confidence or privacy.

- 5.3 You warrant that the Contribution contains no personal information about another person that you are not entitled to publish.
- 5.4 You warrant that the Contribution contains no unreleased examination material.
- 5.5 You warrant that the Contribution contains no malware and no material that is unlawful in Nepal.
- 5.6 You warrant that publishing the Contribution does not breach any obligation you owe to your institution, employer or any other person.
- 5.7 You agree to indemnify us against any claim arising from a breach of these warranties.
- 5.8 These warranties are given afresh on each submission.

6. Withdrawal and what survives it

- 6.1 You may withdraw a Contribution at any time from your dashboard, or by asking us.
- 6.2 On withdrawal we cease publishing the Contribution and remove it from the Service within seven days.
- 6.3 The licence ends for future use on withdrawal, save for the limited survivals in this section.
- 6.4 Copies already downloaded by other users are outside our control and cannot be recalled.
This is a practical limit, not a legal reservation. Anything published publicly may have been saved by someone else before you withdrew it.
- 6.5 Copies held in backups persist until those backups expire in the ordinary cycle, and are not restored to the Service.
- 6.6 We may retain a copy where required by law, or where it is the subject of a live complaint, investigation or legal claim.
- 6.7 Where a Contribution has been quoted or built upon by another user, the quoting material is not automatically removed.
- 6.8 Withdrawal does not entitle you to any payment or compensation.

7. Attribution and identity

- 7.1 We display the name on your account as the author of your Contribution.
- 7.2 If you change your display name, the attribution changes with it.
- 7.3 You may ask for a Contribution to be published under a pseudonym, and we will accommodate that where practical.
- 7.4 If you close your account, you may choose whether Contributions are withdrawn or remain published with your attribution, as set out in the Data Retention and Deletion Policy.
- 7.5 We do not publish your email address, telephone number or any account detail alongside your Contribution.

8. General

- 8.1 If we materially change this agreement, the change applies only to Contributions submitted after it takes effect. Existing Contributions remain governed by the version in force when they were submitted.

A licence you granted last year cannot be widened by a document you never saw. This clause is what makes the version history meaningful for contributors.

- 8.2 The version and date under which each Contribution was submitted are recorded against it.
- 8.3 If any provision of this agreement is unenforceable, it is severed and the remainder continues.
- 8.4 This agreement is governed by the laws of Nepal.
